#### A LITTLE CLUB HOUSE HISTORY

Once upon a time, many years ago, BridgeWater clubhouse had the garbage cans stored out in plain sight, often right in front of the building. Since then, the clubhouse has undergone a serious "face lifts" including exterior paint, new windows, new roof, new front lights, new hardware on the doors and a new awning over the door. Many years before all these improvements were done, Craig Vigliotta, designed and built the wood trash can hiding structure that we have today! ## Let's Talk Trash

HAVE BRIDGEWATER COVANENTS/RESTICTIONS GONE IN THE GARBAGE?

During a recent drive-through of our subdivision by Board members, it was observed that nearly 30 percent of the BridgeWater homeowners are storing their trash bins, on a regular basis, in a location that is directly visible from the street view of their home. This is in stark contrast to what has recently been observed in the adjacent subdivisions of Hartridge, Queensbury, and The Ridge. This behavior reduces the aesthetic of the BridgeWater community and is also in violation of our HOA Covenants agreement (Section 11 - Disposal of Trash).

In an effort to correct this situation, and to alert homeowners of this issue, the HOA Board recently mailed letters to a number of homeowners asking that they store their trash bins in a location on their property that is not visible from the street. For those homeowners who have taken corrective action, we thank you for your compliance and cooperation.

The Board is asking that all homeowners review where they are currently storing their trash bins, understanding that some homes in BridgeWater will be more challenged to comply with this request, due to variations in lot terrain and house orientation. Suggested storage locations to consider are: 1) outside behind your home, or 2) outside on the far side of your home (behind shrubs or a privacy fence), or 3) inside the garage.

Do you have a streetlight out near your home? Maybe the streetlight near you is broken or the pole is damaged? Contact Sawnee EMC. Phone: 770-887-2363 or use the web site: <a href="www.sawnee.com">www.sawnee.com</a> Click on **Report Streetlight Problem** which is a large green button on the main page.

The link will provide a form to fill out. You will be asked to describe the problem, provide the pole number (all street lights are numbered), and provide the closest address including street name and side of the street. In most cases the problem will be fixed in a few days! Don't be left in the dark!



## **Pool Project Update**

The BridgeWater Pool project is still on schedule to be completed by next swim season 2022. Permits have been filed to Fulton County Board of Health and to the City of Johns Creek. The Board has evaluated some of the materials for the project such as renovation pavers, pool basin materials, and tile for the waterline around the pool basin. As soon as the permits are signed by the city and the county, the pool contractor will order the materials. Construction will begin as early as this fall after the pool is closed. If all goes well with the permits and material suppliers, we will be celebrating the opening of a newly renovated pool in Summer 2022!


## **Architectural Review Request Form**

WHAT IS AN ARC?

#### **Preamble statement to the BridgeWater Design Standards:**


Increased values, community pride, personal satisfaction are all driving influences behind the decision to establish the Architectural Review Committee (ARC) for BridgeWater. It is normal for one to sometimes feel animosity toward a group charged with overview of his or her home design. As an attempt to express our cooperative attitude, ARC has adopted and approved these design standards, policies, guidelines, and procedures to aid everyone in working together, to accomplish high quality, planned, and orderly growth and we look forward to serving the BridgeWater Community in the best possible manner."

The purpose of the Architectural Review Committee (ARC) is to provide guidance to homeowners who would like to make improvements, additions, and/or changes to the exterior of their property. Examples of such changes would be exterior painting, building a deck, adding a swimming pool, building a fence, landscaping changes, etc. All homeowners wishing to make changes are expected to submit a plan outlining the change to the ARC committee via the BridgeWater email.
