**THIRD AMENDMENT TO DECLARATION OF COVENANTS,
CONDITIONS AND RESTRICTIONS FOR BRIDGEWATER SUBDIVISION**

THIS THIRD AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR BRIDGEWATER SUBDIVISION is made and entered into this 3rd day of July, 2011 by Bridgewater Homeowners Association, Inc., a Georgia non-profit corporation (the "Association").

W I T N E S S E T H:

WHEREAS, First Federal Savings Bank of Georgia did record that certain Declaration of Covenants, Conditions and Restrictions for Mallard Lake Estates Subdivision on August 1, 1991 at Deed Book 14428, Page 150, Fulton County, Georgia records; which was subsequently amended by that certain First Amendment to Declaration of Covenants, Conditions and Restrictions for Mallard Lake Estates Subdivision recorded on May 13, 1994 at Deed Book 18271, Page 016, aforementioned records, which First Amendment, among other things, changed

the name of the development to Bridgewater Subdivision; by that certain Corrective Amendment to the Declaration recorded on October 4, 1996 at Deed Book 21609, Page 10, aforementioned records; and by that certain Second Amendment to Declaration of Covenants, Conditions and Restrictions for Bridgewater Subdivision recorded on May 5, 2001 at Deed Book 30033, Page 659, aforementioned records (said Declaration, as so amended, being hereinafter referred to as the "Declaration");

WHEREAS, pursuant to Article VII, Section 3 of the Declaration, said Declaration may be amended by a written instrument signed by the owners of the lots with 75% of the votes in the Association and recorded in the Fulton County records; and

WHEREAS, the following Amendment has been approved by a written instrument signed by the owners of the lots with 75% of the votes in the Association as shown by the Certification of Approval attached hereto as Exhibit "A";

NOW, THEREFORE, the Association hereby amends the Declaration as follows:

1. Article VII, Section 3 of the Declaration is hereby deleted in its entirety and replaced by the following:

"Section 3. Duration and Amendment

- (a) **Duration.** This Declaration shall run with and bind the Property, and shall inure to the benefit of and shall be enforceable by the Association, or any Owner, and their respective legal representatives, heirs, successors, and assigns, perpetually to the extent provided by law; provided, however, so long as Georgia law limits the period during which covenants restricting land to certain uses may run, any provisions of this Declaration affected thereby shall run with and bind the land so long as permitted by such law and any such duration shall be subject to the renewal and termination provisions of O.C.G.A. Section 44-5-60, as now existing or as may hereafter be amended. Every purchaser or grantee of any interest (including, without limitation, a security interest) in any real property subject to this Declaration, by acceptance of a deed or other conveyance therefor, thereby agrees that such provisions of this Declaration may be extended and renewed as provided in this Section.
- (b) **Amendments.** Except as otherwise provided for herein, this Declaration may be amended by the affirmative vote, written consent, or any combination of the affirmative vote and written consent of the owners of lots holding Seventy-Five percent (75%) of the votes in the Association. Approval of the required majority of owners to any amendment shall be evidenced by their execution of the amendment or, in the alternative, by the sworn statement of the President, any Vice President or Secretary of the Association attached to or incorporated in an amendment executed by the Association, stating unequivocally that approval of the required majority was lawfully obtained and that all notices required by the Declaration were properly given. In the event a meeting is held

to consider an amendment to this Declaration, notice of the meeting shall state the fact of consideration and state either the subject matter of the proposed amendment or that a copy of the proposed amendment is attached thereto. Owners not present at a meeting at which an amendment is considered may evidence their consent to such amendment, thereafter, in writing. No amendment shall be effective until recorded in the Fulton County, Georgia records.”

2. Except as otherwise defined herein, capitalized terms, as used in this Amendment, shall have the meanings ascribed to such terms in the Declaration.

3. This Amendment shall be effective upon recordation in the Fulton County, Georgia records.

4. Except as herein modified or amended, the Declaration shall remain in full force and effect.

5. In the event of any conflict or inconsistency between the provisions of this Amendment and the provisions of the Declaration or Bylaws, the provisions of this Amendment shall control.
